PREAMBLE:

BLDE **Deemed to be University**) came into existence on the 29th Day of February 2008 with the sole objective of providing quality Medical Education and meeting the health care needs of the people in this backward region of North Karnataka. Shri B. M. Patil Medical College, Hospital & Research Centre, the only constituent college of the University, was established in 1986. It has a unitary campus of 71.2 acres with 24 departments and a teaching hospital with 1218 beds.

The BLDE (Deemed to be University) accredited with 'A' Grade by NAAC (Cycle-2) with CGPA of 3.09 and recognized in 'ATAL Ranking of Institutions on Innovation Achievements' by Innovation Cell, Govt. of India. The Teaching Hospital is accredited by NABH at the entry-level.

Vijaya ENT Care Centre Super-Specialty Otology Centre, having its Centre at #1, 9th Cross, Malleswaram Bangaluru-560 003 caters to needs of postgraduate students of ENT and Fellowship in Micro-Ear Surgery through advanced training programme/practical aspects.

The respective University/ Centre jointly recognize this MOU to mutually cooperate in areas of advanced training and practical exposure in the field of Micro-Ear Surgery and Otology for the benefit for Post-Graduate students of ENT of Shri B.

PURPOSE/OBJECTIVE:

The primary purpose of this MoU is to build academic research/training capacity including research publications and to promote mutual understanding between the University/Centre. The MoU shall formally set out the terms of the cooperative relationship between the parties, establish their respective roles, and facilitate the function of each party in relation to collaborative research /academic training.

Both University/Centre agree to develop collaborative activities in academic areas of mutual interest/ advanced practical training and as equal partners with reciprocity. All academic and research training events are expected to reflect the Post-Graduate students and faculty members in the area of Micro-Ear Surgery, Otology and research publications, particularly in the area of ENT and HNS.

The development and implementation of specific activities based on the MoU shall be negotiated and agreed upon with mutually acceptable terms and conditions.

This MoU is agreed upon on the basis of cooperation between the University/Centre including the following:

- A. The University and the Centre desire to provide training /education/academic collaboration for the Fellowship program in Micro-Ear surgery every year and research publications.
- B. The BLDE University will depute Post Graduate students and Fellowship Program every year at the collaborator Centre.
- C. Both the institutes will be jointly conducting clinical research and making national and international scientific/research publications together.
- D. The Professor & HoD, Department of ENT, BLDE (DU)'s Shri B. M. Patil Medical College, Hospital & Research Centre, Vijayapura shall be Officer in charge for the collaborator Institute.

TERMS OF AGREEMENT

Both University/Centre agreed to carry out the mentioned activities in accordance with laws and regulations of the respective University/Centre after full consultation and approval.
